- 12 Submission of nomination papers duly proposed, seconded by a duly registered voter and signed by the candidate, to the Secretary General on the prescribed form in accordance with the Articles of Association or Rules of the Chamber 19th Aug

- a) The secretary General shall provide a copy of final list of voters to each contesting candidate except the candidate of women seats, as their college is the Executive Committee.
- b) Scrutiny of the nomination papers and letter of authority by the commission. This clause ipso Facto applies to the nominees of the women seats.
- c) Circulation by the Secretary General of the list of nominees whose papers have been declared valid and the forms of withdrawal to the said nominees. This clause ipso-facto applies to the nominees of the women seats.
- 13 The objection if any, to the nomination of candidates can be filed to the Election Commission. This clause ipso facto applies to the nominees of the women seats. Provided that the candidate for a particular seat will file objections for the candidate of the same seat and for the same class. 20th Aug

- 14 The Election Commission will decide the objections filed under the preceding clause. This clause ipso facto applies to the nominees of the women seats. 22nd Aug

- 15 Any candidate, aggrieved by the decision of the Election Commission, taken under preceding clause, where the Commission fails to decide within the time stipulated in the preceding clause may file an appeal to the Director General. This clause ipso facto applies to the nominees of the women seats. 24th Aug

- 16 The Director General Trade Organizations shall decide the appeal preferred under the preceding clause. This clause ipso facto applies to the nominees of the women seats. 30th Aug
2024

- 17 The Secretary General will receive the withdrawal forms from the nominees completed by the nominees who want to withdraw from the Election. This clause ipso facto applies to the nominees of the women seats. (9:00 am to 11:00 am) 31st Aug

- 18 The Commission will issue final list of candidates. (3:00 pm) 2nd Sep

- 19 The polling at the registered office of the Chamber for Corporate as well as Associate Members. Counting of votes shall take place immediately after the polling hours under the supervision of polling officer in the presence of polling agents of the candidates, if any, at the designated site. The Election Commission shall declare provisional results. The Election Commission will conduct election for the seat reserved for Women Entrepreneurs. Provisional results shall be declared by the Election Commission, about the women reserved seats. 5th Sep
